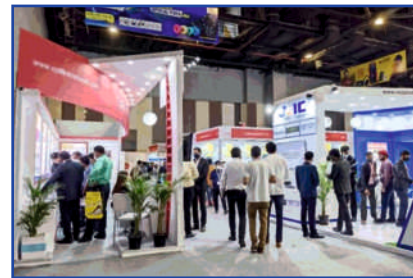

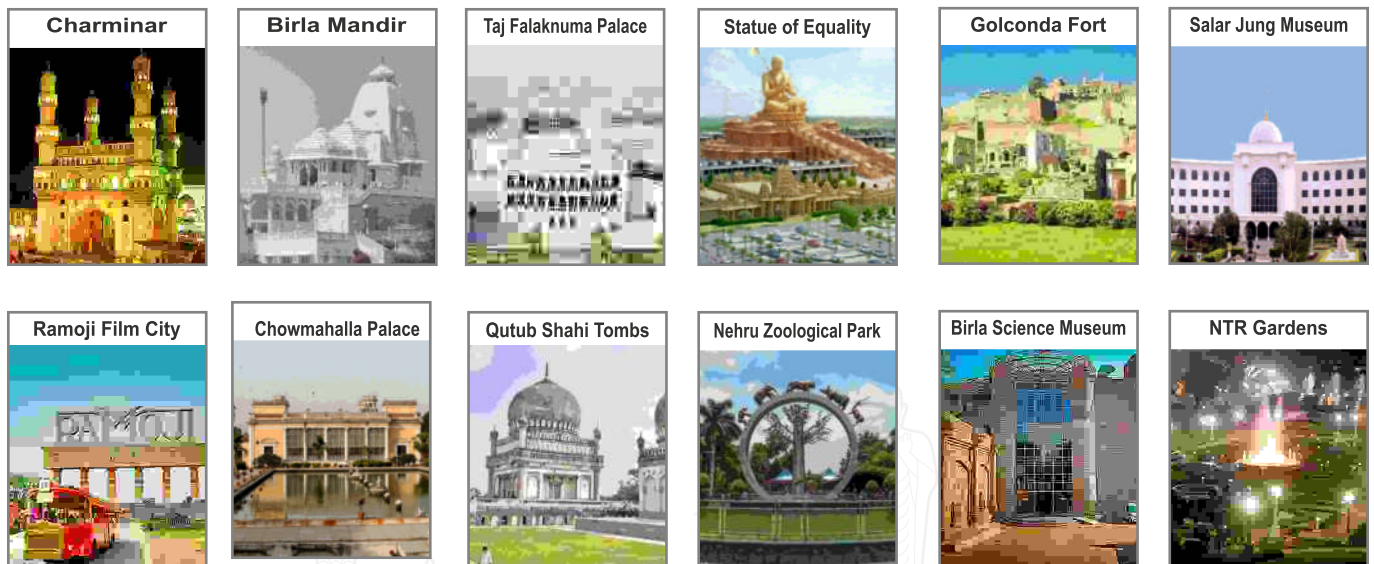
TOURS & TRAVELS

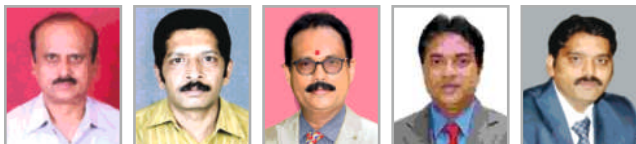

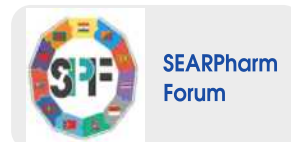
